

Regional Caucus Information for 2024 Elections:

Per the TPMA bylaws, Article VIII, Section 3, "At each annual meeting of the Association, the members from each Region whose Regional Director or Directors' term expires that year shall caucus separately for the purpose of electing the Regional Director or Directors. The Board shall be empowered to define the Regions within the State, determining the number of Regions, and shall determine the number of Directors to be elected from each Region using the ratio guide of one (1) Director for each sixty (60), or fraction thereof, members within the Region. In addition, one Alternate Regional Director is to be elected from each Region; however, the Alternate Regional Director shall not attend the TPMA Board meeting unless the duly elected Regional Director is unable to attend." Region I – 137 members. Eligible for 3 directors.
